(1) Decreased permitted investments limitation to non- investment grade Credit securities rating by one level (Ba3 or higher); and (2) provided a longer period (within 90 days or longer with SERS' written approval) in which the Manager must liquidate a security in the event the security or a counterparty is downgraded to below any of the established credit quality and allocation guidelines, allowing the Manager more flexibility in selling downgraded positions by not forcing liquidation at inopportune times, and providing time to implement a liquidation plan.
