By motion that was moved, seconded, and approved by board members, it was

RESOLVED: That the board accepts the recommendation of the Investment Committee to commit \$300 million to Henderson Park Enhanced Income Fund, LP, plus investment expenses and pro rata share of partnership operating expenses, consistent with executed partnership documents, as an investment within the Real Estate asset class, subject to successful completion of contract negotiations and execution and delivery of closing documents by all parties, including required Commonwealth legal approvals, within 12 months.

RESOLVED: That the board accepts the recommendation of the Investment Committee to commit up to \$100 million to Senior Housing Partnership Fund VI, L.P., plus investment expenses and pro rata share of partnership operating expenses, consistent with executed partnership documents, as a follow-on investment within the Real Estate asset class, subject to successful completion of contract negotiations and execution and delivery of closing documents by all parties, including required Commonwealth legal approvals, within 12 months.

Ms. Sanchez provided a legislative update on Senate Bill 113, House Bill 60 and Senate Bill 240.

b. Chief Investment Officer's Report

CIO Bryan Lewis noted that diversified 401(a) contribution options were established by January 1 for the new Defined Contribution Plan. The defined benefit plan had a down 4th quarter and the 2018 total plan return was -4.6%. Mr. Lewis added that the Investment Office continues to work for better transparency.

c. Chief Financial Officer's Report

CFO Tony Faiola noted that with Linda Engle's upcoming retirement, Sara McSurdy has been promoted to the Assistant Chief Financial Officer position. Ms. McSurdy has been at SERS for 7 years. Mr. Faiola provided mid-year administrative budget and GASB 75 updates. He further noted that SERS was awarded the 2018 Public Pension Standards Award for Funding and Administration and the 2017 Certificate of Achievement for Excellence in Financial Reporting.
