9. REPORT OF EXECUTIVE DIRECTOR

- A. Executive Director Torta provided the following Administrative Update:
- (i) He discussed the telework method that SERS is using post the COVID pandemic. He added that the current hybrid telework method of operation is working well for SERS and that SERS is in a strong position to adapt any future changes in on-site and telework needs;
- (ii) The tentative board meeting schedule for 2023 was released. The proposed schedule has all regular meetings held on Tuesdays and a retreat will be conducted in July. Board members should contact the Executive Director before the December board meeting with any conflicts or comments. The schedule is planned to be finalized at the December meeting;
- (iii) The SERIS 2.0 project executive steering committee has identified that internal staffing is an issue. The Info Matrix contract expires in December, 2022. The committee is looking at all options including strategic contracting.
- (iv) The SOC (System and Organization Controls) audit is in progress with Ms. Karen Lynn, Director of Internal Audit directly overseeing it. This audit looks at the design and effectiveness of internal controls impacting the accuracy of financial data and reporting as well as over the information technology infrastructure. If there are any questions about this audit, please contact the Audit, Risk and Compliance Committee Chair Stacy Garrity or Ms. Lynn;
- (v) Ms. Cindy Collins, Special Assistant to the Executive Director, has been assigned to work with Empower on several initiatives. There have been some issues with the long waiting period for members to withdraw money out of their Empower accounts. Also, an RFP process for the third-party administrator will begin in December, 2022;
- (vi) The 100-year celebration of SERS will happen in 2023. The Communications Office has been assigned to head this project.
- (vii) The legislative calendar is winding down. There were sixteen bills introduced which SERS is tracking. There has been a sponsorship memo circulating regarding a COLA; and
