- (2) to appoint one or more attorneys-in-fact to effect any such sale, transfer, or request for payment.

Furthermore, each such board representative hereby is authorized:

- (1) to make certifications in relation to any such sale, transfer, or request for payment to warrant propriety of same; and
- (2) to agree, in any case where the Uniform Fiduciaries Act may not afford full protection for any such disposition, to reimburse the issuer of such obligation or security and its transfer agent the reasonable costs, including counsel fees, which either may bear in connection with such disposition of any obligation or security held in the name of SERS & CO. or any other name. Further, that all prior authorized securities signature lists established by the board will no longer be effective, including, but not limited to, those established by Resolution Number 2012-03.

- A. Executive Director Torta provided the following Administrative and Legislative Updates:
- (i) Secretary of the Budget Uri Monson was welcomed to the SERS board since his Senate confirmation on August 30, 2023.
- (ii) Recruitment to fill Don Bell's position continues.
- (iii) The responses from the survey of the board retreat have been compiled and the results showed that the retreat was well received. This information will be used when planning the 2024 board retreat.



- (iv) The State College Regional Counseling Center is relocating for security purposes and easier access for SERS members. This move is expected to occur at the end of October, 2023.
- (v) Work on the Strategic Plan by senior leadership will continue with a retreat on October 25.
- (vi) SERS' 100-year anniversary luncheon was a success. Former Board Chair Nicholas Maiale and three former executive directors John Brosius, Eric Henry, and Terri Sanchez were in attendance, along with many current SERS employees. At the luncheon, Senator John DiSanto presented a Senate resolution (ATTACHMENT I) on behalf of Senator Vincent Hughes and himself to acknowledge SERS' 100 years.
- (vii) SERS' staff and actuary continues to draft and cost (respectively) COLA bills, HB 1415 and HB 1416.
- (viii) 2024 tentative board meeting dates have been circulated and will be finalized at the December meeting.
