#### > CIO UPDATES

Jim Nolan, of SERS, provided the Investment Committee with the CIO updates.

## > PUBLIC EQUITY MANAGER STRUCTURE STUDY

Mr. Nolan introduced Tom Shingler, Britt Murdoch, Jay Kloepfer, and Kevin Machiz of Callan. Mr. Shingler provided the Investment Committee with an education session on public equity. Michael Heckmann voiced Representative Miller's desire to eliminate the Emerging Markets asset class from the asset allocation. As a result of this update, a motion by the Investment Committee was made as follows:

MOTION: Do I have a motion to recommend that the State Employees' Retirement Board:

- (i) adopt the proposal to decrease the target allocation to the Emerging Markets Equity asset class by 3%, increase the U.S. Equity asset class by 3%, and approve the corresponding updates to the SERS Defined Benefit Plan's Investment Policy Statement; and
- (ii) delegate authority to the Chief Investment Officer to liquidate Emerging Markets Equity portfolios that do not fit in the new structure?

Notification of all implementation actions pursuant hereto shall be provided at the next regularly scheduled Investment Committee or Board meeting.

➤ REAL ESTATE QUARTERLY PERFORMANCE UPDATE AS OF DECEMBER 31, 2023

Matt Ritter of NEPC, LLC, and Steve Balucha, of SERS, provided the Investment Committee with a review of the Quarterly Real Estate Performance Update, ending December 31, 2023.

## > REAL ESTATE OPPORTUNITY: IPI PARTNERS III-A, L.P.

Mr. Nolan provided the Investment Committee with data on SERS' annual Real Estate portfolio investment pacing, and highlighted the prior investment performance, diversity initiatives, and reporting transparency status for IPI Partners. Mr. Nolan introduced Rob Borski of SERS, who joined Mr. Balucha, and Mr. Ritter in summarizing how IPI Partners would represent a positive fit into the SERS Real Estate portfolio. Matthew A'Hearn and Alexa Singer of IPI Partners then presented IPI Partners III-A, L.P. After the presentation, a motion by the Investment Committee was made as follows:

MOTION: Do I have a motion to recommend that the State Employees' Retirement Board commit up to \$100 million to IPI Partners III-A, L.P., plus investment expenses and pro rata share of partnership operating expenses, consistent with executed partnership documents, as an investment within the Real Estate asset class, subject to successful completion of contract negotiations and execution and delivery of closing documents by all parties, including required Commonwealth legal approvals, within 12 months?
