CIO UPDATES

Jim Voytko, Tony Johnson, Sarah Boctor, and Jason Samansky of RVK provided the Investment Committee with a capital markets update.

➤ ASSET ALLOCATION STUDY

Mr. Voytko, Mr. Johnson, Ms. Boctor, and Mr. Samansky provided the Investment Committee with an education session on asset allocation.

PRIVATE EQUITY OPPORTUNITY: ARCLINE CAPITAL PARTNERS IV LP

Mr. Nolan introduced Kyle Reinfeld, Steve Shank, and Destiny Julo of SERS, and Matt Roche of StepStone. Mr. Reinfeld, Mr. Shank, and Ms. Julo provided the Investment Committee with background information on SERS' Private Equity portfolio and an introduction to Arcline Capital Partners that included an executive summary of the fund's strategy, prior manager fund performance, and transparency reporting status. Mr. Roche further summarized how the Arcline Capital Partners investment fund represents a positive fit into SERS' Private Equity portfolio. Rajeev Amara of Arcline Capital Partners then presented. After their presentation, a motion by the Investment Committee was considered.

MOTION: Do I have a motion to recommend that the State Employees' Retirement Board commit (i) up to \$130 million to Arcline Capital Partners IV LP, and (ii) up to \$20 million to a sidecar vehicle that will coinvest alongside Arcline Capital Partners IV (name TBD), plus investment expenses and pro rata share of partnership operating expenses, consistent with executed partnership documents, as investments within the Private Equity asset class, subject to successful completion of contract negotiations and execution and



delivery of closing documents by all parties, including required Commonwealth legal approvals, within 12 months?
