Narrative/Issues:

New Business

a. Introduction of Revised Agenda, Board Report and Minutes Templates

Ms. Collins advised the Board that staff had worked on creating a set of templates for committee liaisons to use when preparing agendas, minutes, and board reports. The new formats will be in use for the July Board cycle.

b. Fiduciary Review RFP

Ms. Collins described the fiduciary review process and explained that during the last governance review the Board had delegated the responsibility for conducting the fiduciary review to the Board Governance and Personnel Committee. This will be the first fiduciary review the fund has engaged in since 2021, which was a more limited review of certain investment related matters.

The RFP will be issued sometime in the fall, with the anticipation that a vendor will be selected by the end of the year, and the project would begin sometime in the spring of 2026.

After a brief discussion, the Committee unanimously voted to move that the Board Governance and Personnel Committee, consistent with its delegated authority and pursuant to the Fiduciary Review Policy, 2018 BD-POL-14: authorizes SERS staff to initiate the procurement process for SERS' Fiduciary Review Services as described in the attached presentation, and as located on BoardDocs at Agenda Item 6(B).
